Need to Access Capital?

It's been an exciting couple of months with our VT Planning Grant Project and Make Way for Kids Infant/Toddler Capacity Grant both getting under way.

So far, seven projects have been selected for our Planning Grant Project. These projects include community centers, child care businesses, non-profits and employers. Each



applied for funds to explore building or renovating a space for child care in their community. If you want to read more about one of the projects participating in this grant, check out our media release featuring Craftsbury Saplings.

In our second year administering the infant/toddler capacity grant, we received 37 applications for funds – at least one from every county in the state. This grant program supports increased spaces for infants/toddlers in regulated child care in Vermont. FCF administers this program in partnership with the Child Development Division of the Department for Children and Families.

There are additional funding opportunities for both the Planning Grant and Infant/Toddler Capacity Grant. Outside of funding for early care, VT Afterschool Grants are designed to expand afterschool and summer programs for K-12 aged youth, particularly in underserved areas. There are two distinct application tracks; program grants for innovation/expansion and/or small-scale start-ups and center grants to support the creation/sustenance of single-site comprehensive centers.
